## REGISTRATION PROCESS

According to the discipline of his/her choice, the student has 100 hours annualized of courses at IIWM, during which he/she can accordingly to his/her level, have access to individual and group courses (theory, vocal and/or instrumental practice, history of music, analysis, direction, improvisation) and overall practice. In order to complete his professional training within the IIWM, the student shall also enroll in musical or classical chants training courses taking place either at the Conservatoire de Marseille (CNRR), or at the Conservatoire of Aubagne (CRC) or the conservatory closest to its place of residence.

## NECESSARY MODULES FOR THE VALIDATION OF CREDITS

In order to validate one year of courses, it is mandatory to complete either 152 hours for the diploma course (D.E.M.) or minimum 130 hours for the certifying courses (C.E.M./B.E.M.)

- GU ZHENG [Chinese Zither] with Sissy ZHOU / 20h per year / 5 students maximum

- Tailor-made training and personalised accompaniment for individual artists (singers and/or musicians) and vocal and/or musical groups

**METHODS OF SETTLEMENT AND REFUNDING**

- > The payment for the year will be required through wire transfer to our account at time of registration. Our full bank address will be provided by email. One payment per quarter might be considered. An invoice will be provided upon receipt of the payment.
- > Registration fees are due for the current month.
- > Reimbursement conditions apply to students where exceptional circumstances attributable to the IIWM do not permit the continuation of the education (prorated refund), but also for reasons attributable to the student (sickness, move or any major personal circumstances) that could not be anticipated, not allowing the student to complete his or her education (prorated refund on production of supporting documents).
- > Where, after the start of the courses, a student cannot continue his education for duly justified reasons, a withdrawal may be requested by sending a detailed registered letter with acknowledgement to IIWM or by normal post, for which the postmark will be the evidence.
